Special Agent Benedict,

I wanted to bring this to your attention if you are unaware of it. It seems that another person in addition to myself, Alvario Richards, and Special Agent Stephen Tignor has had

a very similar experience with the USSS polygraph unit (they are claiming they were repeatedly accused of being a drug addict and a liar), with the audio of the polygraph being withheld. This person is represented by Sean Bigley at [Bigley Ranish, LLP](#).

I think it would be prudent for DHS OIG to obtain the audio from this person's exam and see what it contains, and if the claims this person is making, which are similar to the complaints I have alleged, are in fact true. This is now three people in addition to myself that I now know of, only from Google searches. The person who contacted me claiming to be from USSS said there are many cases.

Even if the exam was not conducted by Agent Ripperger, if the conduct is similar, it indicates an organized sanctioned pattern of highly inappropriate if not illegal behavior on the part of the USSS polygraph unit.
